Introduction of PFM Strategy 2025-30 Commenced Promoting Sustainable Growth



State Minister for Finance Waseqa Ayesha Khan MP has emphasized the importance of cooperation among policy planners, academics, and development partners to establish a resilient and effective financial management system for Bangladesh, ensuring its economic stability and supporting sustainable growth.

Launching the process for creating the Public Financial Management Strategy (PFM) for 2025-2030 in Dhaka on 19 May 2024, the State Minister said that "PFM Strategy comes at a critical juncture for Bangladesh, as we navigate through unprecedented challenges and opportunities in the global economic landscape". "As we confront the far-reaching impacts of the COVID-19 pandemic, it has become increasingly clear that resilient and effective financial management systems are essential for safeguarding our nation's economic stability and fostering sustainable development", she added.

The State Minister said, "As we embark on this journey towards formulating the PFM strategy, let us remain steadfast in our commitment to excellence, innovation and collaboration. Together, we have opportunity to shape a future where Bangladesh's financial management systems are not only resilient and efficient but also equitable and inclusive, laying the foundation for sustained prosperity for generation to come."

The Inaugural Discussion was organized by the Finance Division, Ministry of Finance with support from the World Bank, European Union and Global Affairs Canada.

Presided over by Dr. Md. Khairuzzaman Mozumder, Secretary, Finance Division, the meeting was attended by Barnard Haven, Acting Country Director for Bangladesh and Bhutan, the World Bank as Special Guest. Shirajun Noor Chowdhury, Additional Secretary, Finance Division made welcome address. Dr. Michal Krejan, Head of Cooperation (HoC), European Union Delegation to Bangladesh, and Sylvia Islam, Senior Development Advisor, Global Affairs Canada also addressed the inaugural discussion. Abu Daiyan Mohammad Ahsanullah, Joint Secretary, Finance Division made a presentation on Pathway to PFM Reform Strategy 2025-2030.

Dr. Md. Khairuzzaman in his speech said enhancing PFM has remained a fundamental aspect of reforms aimed at fostering effective macroeconomic management and promoting good governance. Effective PFM is an essential tool that ties together available resources, delivery of services and achievement of government policy objective.



He however, mentioned that although significant improvement has already been done in PFM reform area in Bangladesh, more coordinated efforts are required from all stakeholders for maximizing the benefits from it.

Barnard Haven in his speech said Bangladesh has made remarkable progress on Public Financial management leveraging new technologies, adding, "I have seen incredible progress on systems like the integrated budget and accounting system, e-procurement and automated payments."

Heven said, "We hope that this collaborative approach will foster an integrated approach to the next generation PFM reforms in Bangladesh that voids fragmentation. It will align with national development objectives and the Smart Bangladesh Agenda, as Bangladesh prepares to reach its upper middle-income objective",

Inaugural session was followed by two technical sessions. The 1st session- "Reflection from the Government Key Stakeholders" was addressed by Rehana Parven, Member (Secretary) Planning Commission, Md. Masud Sadiq, Member (Customs, Policy and ICT), National Board of Revenue and Md. Mofidur Rahman, Additional Secretary, Finance Division. This session was moderated by Md. Adbur Rahman Khan, Additional Secretary Finance Division.

The second session "Voices from other Key Stakeholders" was moderated by Suraiya Zannath, Lead Governance Specialist, Financial Management, the World Bank. It was addressed by Mohammad Muslim Chowdhury, former Comptroller and Auditor General, Ramendra Nath Biswas, Director General, Institute of Public Finance and Dr. Monzur Hossain, Research Director, Bangladesh Institute of Development Studies.

Mohammas Saiful Islam, Additional Secretary, Finance Division and National Program Director, Strengthening Public Financial Management Program to Enable Service Delivery (SPFMS) made the closing remarks.

The Government of Bangladesh recognizes the critical importance of strengthening its PFM system to effectively manage public resources, foster transparency, ensure accountability, and promote sustainable development. Effective PFM systems drive strong institutions, economic

stability, resource efficiency, and public service excellence.

Over the past four decades, Bangladesh made significant strides in reforming its PFM system, starting with creation of Committee on Reforms in Budget and Expenditure Control (CORBEC) in 1989 followed by several reform initiatives including Reforms in Budgeting and Expenditure Control (RIBEC) Project, Financial Management Reform Project (FMRP), Strengthening Public Expenditure Management Program (SPEMP), Public Expenditure Management Strengthening Program (PEMSP), Strengthening Public Financial Management Program to Enable Service Delivery (SPFMS).



Earlier, two robust PFM Reform Strategies were formulated for 2007–12 and 2016–21 to take forward the ongoing agenda of reforms and establish broader ownership of the reform process by government.

Bangladesh now seeks to transform its PFM system into a technology-driven, enhanced performance orientation and efficient public expenditure management system to support improved service delivery and sustainable development. The PFM Reform Strategy 2025–2030 aims to address gaps and outstanding issues of previous PFM reform initiatives; cover broader political mandates– Smart economy, Smart citizens etc. in alignment with PFM functionalities.

Comprehensive Gender Budget Report Crucial for Making Smart Bangladesh



State Minister of Finance Waseqa Ayesha Khan, MP underlined that a comprehensive Gender Budget Report is crucial for Making Smart Bangladesh. Addressing the workshop on Developing Gender Budget Report 2024–25 as the Chief Guest Waseqa Ayesha Khan said, despite the substantial headway in women's development under the leadership of Prime Minister Sheik Hasina, women in the country are still grappling with challenges such as being bound by religious taboos, limited utilization of information technology, feelings of insecurity, and insufficient workplace amenities. She said the Government is planning to increase the budget to develop the capacity of women.

Addressing the workshop, held at the Finance Division in Dhaka on 15 May 2024, the State Minister said the Government is planning to increase the budget to develop the capacity of women.



Presided over by Secretary Finance Division Dr. Md Khairuzzaman Mozumder, the workshop was addressed by Women and Children Affairs Secretary Nazma Mobarek as special Guest. Mohammad Saiful Islam, Additional Secretary, Budget-1, Finance Division, Ministry of Finance and National Program Director of Strengthening Public Financial Management Program to Enable Service Delivery (SPFMS) made welcome address.

Nazma Mobarek in her speech said that Bangladesh has maintained the top position in terms of female leadership among South Asian countries for the past 9 years. She however, regrated over the high rate of dropouts in services due to the prevalent issue of shouldering the 'care burden' within families.

Dr. Md Khairuzzaman said that the Government intends to extend the Gender Budget Report preparation to all ministries starting next year. At present this report is being prepared covering 44 ministries. The gender budget was prepared earlier on manual basis. The Finance Division recently implemented a gender budget tracking system for the first time using its iBAS++ (Integrated Budget and Accounting System) program. This system allows for the monitoring of allocated budget usage and reporting on specific areas.

A presentation on Gender Budget Report 2024–25 was made by Mahedi Masuduzzaman, Joint Secretary Finance Division where five thematic areas with gender relevance have been identified including women's empowerment and social status enhancement; economic participation and equality, increase women's effective access to public services; education, health and well-being for women's development.

The presentation highlighted the obstacles faced by women in Bangladesh, such as low participation in the labor force, income inequality, workplace difficulties, reproductive health rights, nutritional concerns, early marriages, and harassment.

Single Registry System MIS for Social Protection Schemes



Cabinet Secretary Md. Mahbub Hossain said that the cabinet, under the leadership of Prime Minister Sheikh Hasina, has placed a strong emphasis on social security and has issued directives to guarantee assistance to those truly in need.

Addressing a workshop on Single Registry System (SRS) MIS for Social Protection as the chief guest, he mentioned that the social security portfolio had expanded to Taka 1260.90 billion in the fiscal year 2023-24, with over 60 million individuals benefiting from social protection initiatives in Bangladesh.

The workshop, jointly organized by Cabinet Division and Finance Division with technical support from the European Union-funded project TASSSR, held at Hotel InterContinental Dhaka on 21 May 2024.

Presided over by Finance Secretary Dr. Md. Khairuzzaman Mozumder, the workshop was attended by Md. Mahmudul Hossain Khan, Secretary, Coordination and Reforms, Cabinet Division as special guest. The function was also addressed by Mohammad Saiful Islam, Additional Secretary, Finance Division and National Program Director, Strengthening Public Finance Management to Enable Service Delivery (SPFMS), Mohammad Khaled Hasan, Additional Secretary, Coordination, Cabinet Division among others.

The workshop aimed to introduce the proposed conceptual model of the social protection single registry for Bangladesh and to showcase the single registry system, seek policy-level advice from the policymakers, and identify major obstacles to address.

Dr. Md. Khairuzzaman Mazumdar stated in his address that the conceptual model of the SRS has been turned into a tangible reality. He mentioned that Finance Division is developing the SRS for social security programs for Cabinet Division which is responsible for coordinating the social safety net program in Bangladesh. Currently, the Finance Division is improving the distribution system of beneficiaries through G2P (Government to person), the Secretary said adding, 29 percent of the population is covered by social protection schemes. He mentioned that social protection implementation consists of two main areas: distribution and targeting. Cash programs for social protection are distributed through G2P, covering 93 percent of the beneficiaries. This has led to a decrease in corruption during payment distribution to the recipients.

Mohammad Saiful Islam delivered a presentation outlining the essential characteristics of the SRS, its components, the G2P payment process, the relationship between GRS and SRS, the monitoring and evaluation dashboard, the SSN Portal, reporting capabilities, and other conveniences.

Mohammad Khaled Hasan emphasized the significance of the SRS beneficiary selection, stating that the SRS serves as a medium for MIS to communicate effectively and promote coordination and interoperability between various software and databases. This aids in beneficiary selection, monitoring, and policy-making processes.

Training Workshop on Verification of Draft Manual of Economic Code



Thirty-six batches of training workshops were conducted for 446 participants on the Verification of Draft Manual of Economic Code. The workshops took place from 12 March to 2 April 2024, organized by the iBAS++ scheme under the SPFMS Program.

The Budget and Accounting Classification System (BACS) provides a logical framework for classifying government financial transactions, ensuring revenues and expenditures are easily recorded, reported, and analyzed. A classification system is crucial for transparent and accountable Public Financial Management (PFM). Without a consistent classification system, analyzing and reporting on demand is nearly impossible for efficient PFM.

With the approval of His Excellency the President, the new Budget and Accounting Classification System (BACS) was implemented as determined by the Comptroller and Auditor General of Bangladesh, starting from the financial year 2018–19. Article 21 of Accounts Code volume 1 addresses this classification system, and the BACS is included as annexure–I in Accounts Code volume 1.

Volume III of annexure-I in Accounts Code volume 1 deals with the segments of Fund, Economic, Mode of Financing, Locations, Authorization, COFOG, and Budget Sector. An important aspect of the new BACS is the explanation of economic codes. This is crucial, as it will ensure that budget allocation and spending are aligned with their intended purposes, promoting transparency, accountability, and discipline in public expenditures.

A draft manual on the description of economic codes has been prepared in accordance with existing laws, rules, and regulations, and it will be an essential part of annexure-I in Accounts Code volume 1.

Training on DDO and Other Bills

Training on DDO and Other Bill was organized for 27 officials to develop their capacity as the master trainer. Later, they provided training to 569 officials in 25 batches held between 18 May 2 June 2024.

DDO Other Bills is a component of iBAS++. The Government of Bangladesh has given top priority to promoting digital payments in order to expand digital payment services to all sectors of the country.

This electronic billing system involves the online transmission of bills and receipt of payments. It serves as a paperless alternative to traditional billing methods, providing details on payment deadlines and terms.

The integration of DDO Other Bills within an accounting system has the potential to produce several favorable results.



The desirable outcomes of e-Bill in an accounting module include time and cost savings, faster payment cycles, improved accuracy, enhanced customer satisfaction, better record-keeping, improved communication, integration with accounting systems, and environmental sustainability.

Workshop on Social Security Activities Report 2024-25



Workshop on Social Security Activities Report 2024–25 was held in three batches between 2 May and 7 May 2024 with 157 participants from different line ministries.

The purpose of this workshop was to develop the capacity of assigned officials of different line ministries to develop Social Security Activities Report in an organized and comprehensive manner.

Shirajun Noor Chowdhury, Additional Secretary, Budget & Expenditure Management, Finance Division, Ministry of Finance participated the workshop as the chief guest. He emphasized on implementation of the National Social Security Strategy (NSSS) of Bangladesh 2015. Every year finance division prepares the social protection budget and reports. The existing social protection report should comply with the National Social Security Strategy.

Mohammad Saiful Islam, Additional Secretary, Finance Division and National Program Director, Strengthening Public Finance Management to Enable Service Delivery

Program (SPFMSP) made a presentation on the Single Registry System of Social Protection. He also mentioned that the social protection program's operation code and economic code should be identified to align with the iBAS++ System. Besides, lifecycle and thematic cluster reports will be separately identified for social protection reporting. The Single Registry System will make it easier to monitor and evaluate social protection programs.

The Finance Division issued a circular to all line ministries to prepare a complete report covering all activities related to social activities.

Training on Online Leave Audit Register

iBAS++ has created a new online leave audit register to streamline the leave management process for government employees, eliminating the need for the time-consuming traditional system. A sub-module has been developed.



A total of 31 batches training programs for relevant system users of the new online leave audit register was held between 30 April and 6 June 2024. Throughout this training period, 739 government officials underwent training on the procedures for processing leave requests online. The purpose of this module is to streamline the leave management process. The procedure involves submitting leave requests online, obtaining approval for leave, and maintaining leave records by the accounting department in real-time. System generated leave certificate and dynamic leave account will be prepared through iBAS++.

Workshop on Leveraging ISO 27001 Certification for PFM Reform



A workshop on iBAS++ and the Path to Excellence: Leveraging ISO 27001 for PFM Reform was held on 27 April 2024 at Fortis Downtown Resort to create awareness about ISO, its roadmap and preparedness for ISO certification.

Md. Hasanul Matin, Additional Secretary, Budget-2, Finance Division and PIT Head, BACS & iBAS++ participated the workshop the chief guest.

The in-depth discussion was held in the workshop around the actions and the process through which iBAS++ obtained the certificate and the strategy on how to utilize ISO 27001 for Public Financial Management (PFM) reform in iBAS++. iBAS has consistently adhered to the standards and ensures that all consultants are well-informed about them on a regular basis.

It was an eventful workshop. There were different types of brainstorming and discussion session and also recreational games.

Workshops on different aspects of draft Medium Term Macroeconomic Policy Statement (MTMPS) 2024-25 to 2026-27



'Improvement of Fiscal Forecasting through Development of Macroeconometric Model Scheme of Strengthening Public Financial Management Program through Enabling Service Delivery (SPFMS)', Finance Division has organized a series of workshops on different aspects of draft Medium Term Macroeconomic Policy Statement (MTMPS) 2024–25 to 2026–27. The events took place at the Finance Division. The workshops were presided over by Mofidur Rahman, Additional Secretary, Treasury and Debt Management Wing and moderated by Dr. Ziaul Abedin, Additional Secretary, Macroeconomic Wing.

'Navigating through Dynamic Global Landscape'

The first workshop on 'Navigating through Dynamic Global Landscape' was held on 16 April 2024 at the Finance Division. Sulekha Rani Basu, Additional Secretary (Regulation, Implementation & SOE), Finance Division was present as the Chief Guest. Dr. Rashedur Rahman Sarder, Deputy Secretary presented on first chapter of MTMPS. The participants of the workshop discussed various aspects of improving the quality of MTMPS considering Public Expenditure and Financial Accountability (PEFA) framework and other related surveys and reports. The guests and participants were emphasized to include important element including the impact of global economic conditions, international events, and their short-term and long-term implications on the economy of Bangladesh, as well as proposed potential measures to address them in the publication. The discussants were suggested to restrict the statistics within the trading partners and the commodities that are relevant for us. Moreover, some requested to make the table and graph more readers friendly. The chief guest in her speech remarks that "the government is working towards achieving three main macroeconomic goals, including – sustainable economic growth, keeping commodity prices stable, and ensuring employment. To achieve these goals there is no alternative to formulating a coherent medium-term macroeconomic policy framework (MTMPS)", she added.

'Domestic Macroeconomic Trend and Medium-Term Outlook

The second workshop on 'Domestic Macroeconomic Trend and Medium-Term Outlook' was held on 17 April 2024 where Shirajun Noor Chowdhury, Additional Secretary, Finance Division was present in the event. The presenter of the workshop, Tawhid llahi started with the presentation of the second chapter of the MTMPS which is dealing with the Domestic Macroeconomic Trends and Medium-Term Outlook. This chapter incorporates the assumptions relating the sectoral estimates under the Medium-Term Macroeconomic Framework (MTMF), along with an indication and explanation of the divergence between previous years' budget estimates and actual outturns. Tawhid elaborated on the Real sector and Fiscal sector. Then Suhana elaborated Monetary Sector and External Sector in detail. By taking part in the last conversation, Shirajun Noor chowdhury, Addition secretary expressed the view that selected macroeconomic indicators can be compared with the targets of the mid-term review of the 8th Five Plan.



Furthermore, he suggested presenting the deviation against both the original budget and the revised budget. He emphasized the need for strategic planning in resource allocation.

'Revenue Outlook and Mobilization Strategy'

The third workshop on 'Revenue Outlook and Mobilization Strategy' was held on 18 April 2024 where Md. Abdur Rahman Khan FCMA, Additional Secretary (Admin and TDM), Finance Division (Now the Secretary, Financial Institutions Division) was present as Chief Guest. Abul Monsur, Additional Secretary, Bilquis Jahan Rimi, Additional Secretary (Expenditure Management) and Mohammad Jahirul Quayum, Joint Secretary, Budget Monitoring, Evaluation and Reporting, Finance Division were present as discussant. The participants in the workshop expressed different views about revenue mobilization. These include the use of local administration in cases where NBR is unable to collect taxes due to lack of manpower; raising corporate taxes; monitoring the profit share of state-owned enterprises; bringing local administrations under the iBAS++ system; increase allocation for human resource development; enhancing law enforcement and monitoring activities to prevent tax evasion and formulating tax policies.

'Government Expenditure and Debt Management'

The fourth workshop on 'Government Expenditure and Debt Management' was held on 21 April 2024 where Manzarul Mannan, Additional Secretary, Finance Division was present as Chief Guest.



Mannan commented that "ensuring quality expenditure is necessary for proper implementation of the government's budget. At the beginning of the year many ministries formulate budget plans which in many cases do not correspond to reality. As a result, many ministries cannot spend a measurable amount of the budget. The government is implementing the Public Financial Management (PFM) Reform program to remove such bottlenecks. Government Expenditure and Debt Management is one of the topics organized for developing a workable document on Medium Term Macroeconomic Policy Statement (MTMPS). A total of 30 officials from various branches of the Finance Division participated in the workshop.

'Fiscal Risks and Way Forward'

The fifth and last workshop on 'Fiscal Risks and Way Forward' was held on 22 April 2024 where Shirajun Noor Chowdhury, Additional Secretary (Budget & Expenditure Management), Finance Division was present as Chief Guest. Chowdhury stressed the importance of conducting a series of consultations to complete the document and recommend using the data and information from reliable sources like the International Monitory Fund (IMF) or World Bank.



Homayra Begum, Additional Secretary (State Owned Enterprise–SOE), Md. Firoz Ahmed, Additional Director General–2 (Joint Secretary), Finance Division, and Monir Hossain Chowdhury, Joint Secretary (Admin), Finance Division were present as discussants. Dr. K M Alamgir Kabir, Deputy Secretary for Macroeconomic–2, and Asif Iqbal, Deputy Secretary for Monitoring–1, the Finance Division were present on the chapter related to fiscal risk and the tools and procedure to manage fiscal risks effectively. Relevant officials of the Finance Division participated in the workshop.

Workshop on "Classification of Functions of Government (CoFoG) Mapping"



Improving Pension Management System and Quality and Timeliness of Financial Reporting Scheme under Strengthening Public Financial Management Program to Enable Service Delivery (SPFMS) organized a series of training workshop on "Classification of Functions of Government (CoFoG) Mapping" in April and May 2024 at the SPFMS program office in Dhaka.

Representatives from the Finance Division, Financial Management Academy (FIMA), Chief Financial Officers (CFOs), along with officials from Controller General of Accounts (CGA) and SPFMS attended the workshops.



In the training session, Mohammad Saiful Islam, Additional Secretary (Budget-1) & National Program Director, SPFMS Program made a presentation on CoFoG Mapping mentioning the purpose of the training and the future plans to align the COFOG with budget planning. Amir Uddin provided an overview of the progress and planning for CoFoG Mapping implementation. He further discussed the issues that were identified in previous workshops and provided insights on potential solutions.

The training workshops were also facilitated by Tanveer Akhter Hossain Khan, Director General of the Civil Audit Directorate, Zahirul Islam and Md. Rukan Uddin, consultants, Pension Scheme among others.

The first batch of the workshop on CoFoG Mapping was held from 20–21 April 2024, followed by second batch from 26–28 April, 2024, third batch from 4–5 May 2024, fourth Batch 7–9 May, 2024 and fifth batch from 15–16 May 2024.

Training on IPSAS Certification Examination

The 14-week training program on International Public Sector Accounting Standards (IPSAS) from January to April 2024 has concluded. The training sessions took place every Friday and Sunday throughout the 14-week period. Pension Management and Financial Reporting Scheme, SPFMS program arranged the training program for 50 officials from Finance Division, OCAG, CGA and SPFMS program on IPSAS (International Public Sector Accounting Standard) certification course in two batches.

The training program was inaugurated on 12 January 2024 with Abul Kalam Azad, Controller General of Accounts as the Chief Guest. Presided over by Mohammaad Saiful Islam, Additional Secretary and NPD, SPFMS program, Tanima Tasmin, PEC, Pension Scheme made address of welcome.

Abul Kalam Azad in his speech said the IPSAS training would help the participants understand the importance the IPSAS acrual basis of accounting. Mohammaad Saiful Islam expected the participants will work for the smooth transition of IPSAS cash to IPSAS accrual basis of accounting.

The training was a continuation of the previous four batches of IPSAS training. The purpose of the training is to train the participants to prepare for the IPSAS examination. So far, 70 participants has got the IPSAS certifications.
